
Circular No. 10 of 2017-18

In continuation to this Department's Circular no.F.3 (556)/policy/VAT/2015/1366-71 dated 27.01.2016 whereby the conditions specified in Para 4 of Circular no.30 of 2015-16 bearing No.F.3(556)/policy/VAT/2015/1028-34 dated 18.11.2015 were modified, for issuance of Statutory Forms under CST Act, 1956, the said Para 4 of the Circular no.30 of 2015-16 is further modified to include the following after the sentence, "*if ratio still falls below 45%....and so on*".

"If the ratio still falls below 45% then Forms shall be allowed to be downloaded only after proper scrutiny of returns and examination & verification of related documents etc. by the Ward In charge concerned and with the prior approval of the respective Zonal In charge, provided that the dealer concerned makes an on line request to that effect to the Ward In charge concerned."

The rest of the contents of the above said Circular shall remain the same.

This issue with the prior approval of Commissioner, VAT.




