**NOTIFICATION**

F.No.F.5(54)/Policy/VAT/2013/PF-- Whereas, the Ministry of External Affairs, Government of India, has requested the Government of National Capital Territory of Delhi to grant facility of VAT exemption/refund to **South Asia Regional Training and Technical Assistance Center (SAARTAC)** in New Delhi, in accordance with the principle of reciprocity, on all taxable goods as per the prevailing rules and norms vide their letter No.D-II/451/16(02)/2016 dated 22<sup>nd</sup> March, 2017.

And, whereas, I, H. Rajesh Prasad, Commissioner, Value Added Tax, Government of National Capital Territory of Delhi, am of the opinion that it is expedient in the public interest so to do.

Now, therefore, in exercise of the powers conferred by sub-section (2) of Section 103 of the Delhi Value Added Tax Act, 2004 (Delhi Act 03 of 2005), I hereby make the following amendments in the Sixth Schedule of the said Act namely:

**AMENDMENTS**


