3. Before participating in the Public auction, the participant/intended bidder will have to deposit earnest money of Rs.7000/- through "Demand Draft" of Schedule Banks in favour of "Commissioner, Trade & Taxes, Delhi" payable at Delhi.
4. The Public Auction will be held on 27.12.2017 at 03.30 PM in the presence of all participant/intended bidders.
5. In case of any holiday falls on 27.12.2017, the public auction will be extended to the next working day at same time.

9. The highest bidder will have to submit proof of his/her identity (Copy of Aadhar Card/Voter Card or any other authentic proof) on the day of auction.
10. Highest bidder will have to deposit 50% of the bid amount offered by him/them at the time of open bid auction through cheque in favour of Commissioner, Trade & Taxes, Delhi".
11. The successful bidder will have to deposit the **ENTIRE BID AMOUNT** through **"Demand Draft"** of schedule banks in favour of "Commissioner, Trade & Taxes, Delhi" payable at Delhi.
12. The successful bidder will have to remove the vehicle at his own cost within 05 days after depositing the entire bid amount.

The successful bidder will have to submit an UNDERTAKING on a judicial stamp paper of Rs.10/- that he/she/they will SCRAP the vehicle and have to deposit the **"Cutting of the Engine number plate"** within **07** days from the removing the vehicles from the department. (format of undertaking will be given at the time of auction)
14. The cheque of the 50% amount received against highest bid taken on the day of public auction and demand draft of EMD of Rs.7000/- shall be returned to the successful bidder, after receipt of **"Cutting of the Engine number plate"**.
15. The earnest money of Rs.7000/- will be returned on the same day to the unsuccessful bidders after closing the Public Auction.
16. No RC in respect of auctioned vehicle or NOC shall be given by the department.
17. Other terms & conditions shall be declared at the time open spot auction.
18. The Auction Committee/Team reserve the right to accept or reject the highest bid without assigning any reason.
19. If the successful bidder(s) failed to deposit the requisite bids amount at any stage, the earnest money shall be forfeited.
