ORDER

In exercise of the powers conferred by Section 68 of the Delhi Value Added Tax Act, 2004, (Delhi Act 3 of 2005), read with Rule 48 of Delhi Value Added Rules, 2005, I H. Rajesh Prasad, Commissioner (State Tax/ VAT), Department of Trade & Taxes, Govt. of NCT of Delhi, do hereby delegate my powers under sub-section (1) of Section 74 to the officers specified in column No.4 of the table appended below and direct that these officers shall exercise the powers and perform the duties concomitant with such powers and jurisdiction specified in column No.5. **The said powers are delegated only for the cases upto Rs. 5 lakhs pertaining to the financial year 2007-08 to 2015-16 in respect of the wards mentioned against the name of respective officers.**

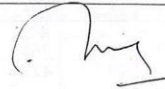

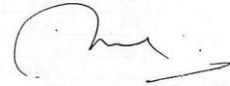
