## ORDER

- 1. A case has come to the notice of the department recently where a proper officer has issued refunds to non-existing or non-functional firms. Several of these firms applied for migrating from the previous ward of the proper officer to the newly allotted ward following their transfer, and such applications were promptly allowed without proper verification. The volume of refunds issued is seen to be disproportionately high compared to refunds issued in the ward during the previous periods. The department has already initiated action in this regard.
- 2 To prevent such malpractices in future, the following action is to be taken
  - i. All Zonal In-charge are directed to comprehensively review all their wards and the refunds issued by them to notice any tell-tale signs of malpractices of the kind indicated above. If any such instances are noticed, they may be brought to the notice of the Special commissioner (Vigilance) with a copy to Commissioner (T&T) latest by 10<sup>th</sup> October 2021.
  - Special Commissioner (Vigilance) should immediately initiate departmental as well as criminal action if any such malpractice is discovered.
  - iii. If no such case is discovered in a zone, a line in confirmation should be submitted to the Vigilance branch latest by 10<sup>th</sup> October 2021. The consolidated confirmations should be submitted to Commissioner (T&T) by 12<sup>th</sup> October 2021.
  - iv. The Vigilance branch, in consultation with Systems and EDP branch should develop an SOP for detecting such cases, as also for implementing future safeguards in the refund process (taking existing guidelines into account) and submit the same latest by 10<sup>th</sup> October 2021.
  - v. The Vigilance branch, in consultation with Systems and EDP branch will independently run data analytics to discern if there exist any wards where refund orders show characteristics of the type mentioned in Paragraph 1 of this order. Report to be submitted by 10<sup>th</sup> October 2021.
  - vi. All Zonal Officers are directed to periodically review the refunds being issued at ward level and initiate disciplinary as well as criminal action wherever any malpractice is discovered.
- Strict compliance may be ensured by all concerned.
