3. On the basis of analysis of data as per GST portal / GST prime in respect of M/S MAA BHAWANI TRADING COMPANY, through AIO, it is observed during 2022-23, 2023-24 and 2024-25, M/S MAA BHAWANI TRADING COMPANY has generated the E way bills without declaring the supply in GSTR 1 and GSTR 3B involving GST Rs.2,86,08,122/-. The details of recipient as per E way bill portal data is given in **Annexure A.**

4. On the basis of analysis of data as per GST portal in respect of M/S MAA BHAWANI TRADING COMPANY, through AIO,, it is observed that the firm has passed on ITC amounting to Rs.21,12,685/- during the period of 2022-23, 2023-24 and 2024-25. The details of recipient as per GST1 M data is given in **Annexure B.**

5. On the basis of analysis of data as per GST portal in respect of M/S MAA BHAWANI TRADING COMPANY, through AIO,, it is observed that the various suppliers firms has passed on/Generated Eway bills for inward supply to M/S MAA BHAWANI TRADING COMPANY involving ITC of Rs.37,84,121/- during the period of 2022-23, 2023-24 and 2024-25. The details of suppliers as per GST 2A / E-way bills for Inward supply data is given in **Annexure C.**

6. Further, on scrutiny of PAN card of M/s MAA BHAWANI TRADING COMPANY (GSTIN: 23NYWPS9155K1Z2) (Legal Name: Anil Sharma), it has been found that there is no other firms registered on same PAN No. NYWPS9155K.
