**VACANCY CIRCULAR**

**Subject:** Filling up five (05) vacancies in the grade of Staff Car Driver (Ordinary Grade) (General Central Service, Group C, Non-Gazetted, Non-Ministerial) in Level-2 of pay matrix (Rs.19900-63200) in the Department of Trade & Taxes, Govt. of NCT of Delhi, on Deputation/ Absorption basis-reg.

It is proposed to fill up five (05) vacancies of Staff Car Driver (Ordinary Grade) (General Central Service, Group C, Non-Gazetted, Non-Ministerial) in Level-2 of pay matrix (Rs.19900- 63200) in the Department of Trade & Taxes, Govt. of NCT of Delhi, on Deputation/Absorption basis.

**2. Eligibility Conditions:**

**Deputation/Absorption:-**

(a)(i) Holding analogous post on a regular basis in the parent cadre or department

or

(ii) From amongst Group C employees in Level-1 (18000-56900/-) in Pay Matrix with three years of regular service in the office where vacancy arises failing which from Group C employees in Level-1 (18000-56900/-) in Pay Matrix with three years of regular service in Central Government/State Government/UT territories and on the basis of a driving test to assess the competence to drive motor cars.

and

(b) possessing the following qualification and experience as mentioned for direct recruits which are as under:-

- i) Possession of valid driving license for motor cars;
- ii) Knowledge of motor mechanism (the candidates should be able to remove minor defects in vehicle);
- iii) Experience of driving a motor car for at least three years; and
- iv) 10th standard pass

**Desirable:** Three years' service as Home Guard/Civil Volunteers.

**Note 1 :**Qualifications are relaxable at the discretion of the Competent Authority in the case of candidates otherwise well qualified.

**Note: 2 :**The qualification(s) regarding experience is relaxable at the discretion of the Competent Authority in the case of candidates belonging to Scheduled Castes or Scheduled Tribes if at any stage of selection the Competent Authority is of the opinion that sufficient number of candidates from these communities possessing the requisite experience are not likely to be available to fill up the vacancy reserved for them.

**Note 3:** The period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organisation/Department of the Central Government/State Government/UT territories shall ordinarily not exceed three years.

**Note 4:** The maximum age-limit for appointment by deputation/absorption shall not be exceeding fifty-six years as on the closing date of receipt of applications.

### 3. Regulation of pay and other terms of deputation:

The pay of the selected candidate will be regulated under the provisions contained in the DoP&T O.M.No06/8/2009-Estt.(Pay-II) dated 17/06/2010 as amended from time to time.

### 4. Age-limit:

The maximum age limit for appointment on deputation/absorption basis shall not exceed fifty-six years as on the closing date of receipt of application


### 5. Period of deputation:

Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in same or some other organization/Department of Central Government/ State Government/ UT territories shall ordinarily not exceed three years.

6. Application (in duplicate) only in the prescribed proforma (Annexure-I) of the eligible candidates whose services can be spared immediately on selection, together with the certificate from the forwarding Authority (in proforma Annexure-II) along with the following documents:-

- i) Integrity certificate
- ii) List of major/minor penalties imposed if any, on the official during the last 10 years;(if no penalty has been imposed a 'Nil' certificate should be enclosed).
- iii) Vigilance clearance certificate.
- iv) Attested photocopies of APARs for the last five years (2019-20 to 2023-24) (attested on each page by an officer not below the rank of an Under Secretary to the Government of India).
